"What did I learn most from this course?" It's indeed a very tough question to answer as I learned a lot of things from this course. I came to know that TJ, as a practice, can provide a template for addressing the legacy of atrocities, both historic and contemporary. A number of national and international experts who have first-hand experiences of working on TJ in different parts of the world have shared their knowledge and experiences with us. From them we come to know that far from being a "one-size-fits-all" prepackaged solution for dealing with the past, transitional justice takes on many different forms in different cultural, geographic and temporal contexts. Ttransitional justice implies a much wider process of dealing with the past that goes beyond ordinary criminal justice. Indeed, the transformative impact of courtroom trials rapidly fades in the absence of other transitional justice mechanisms such as truth commissions, reparations or institutional reform. This course has enhanced and broadened my outlook and has provided me with an in-depth knowledge about International Crimes and what are the basic as well as subtle differences among them. I'm not from law background, but an academician and practicing teacher in English, even then I myself

created a Truth Commission, analysed and investigated given situations where International crimes were or have been occurring, and then led the prosecution team, which was followed by suggesting different reparations programs and institutional reforms. All these happened in the process of the course. Here like students, we work in groups. And throughout it was learning with pleasure in the time when the whole world is facing an unprecedented devastating situation.

As an academician and lecturer in English at the National University of Bangladesh, I would love to share my experiences with my students in order to make them aware of TJ, human rights violations, international crimes and laws, and all other aspects related to TJ; so that in future they can play an active role in making this world a more loving and enduring place free of torture and mass human rights violations for future generations. What did you learn most from the course? Sometimes words get shortage to express our thoughts. This course is more than an online course. Thus what I learned will be divided into 2 parts.

I. What I learn about transitional justice : Transitional Justice refers to the ways in which countries emerges from the period of conflict and repression or war or political transition address large grave and systematic human rights violation which are so grievous and numerous that a normal justice system will not be able to deal and response in adequate way to redress such violations.

What transitional justice is not? Obviously, it is not the way to fix everything which is wrong or injustice with society. Rather it is longterm social and political struggles for justice and equal opportunities that might be assisted by measure of transitional justice but transitional justice cannot solve it.

The few constant aims of transitional Justice are a) establish accountability of institutions and restore confidence in them, b) makes access to justice a reality for the most vulnerable in society/ victims in the aftermath of human rights violations, c) ensures that women and marginalized groups play an effective role in the pursuit of a just society,

d) respect for the rule of law Facilitating peace processes and fostering durable resolution of conflicts. Four pillar of transitional Justice are :

i. Truth seeking or fact finding processes into human rights violations by non-judicial bodies.

ii. Criminal Prosecution for the perpetrator/s.

iii. Reparations for human rights violation. For instance : individual, collective, material, and symbolic.

iv. Reform of laws and institutions. For example : judiciary, military, and military intelligence.

II. Other things that I have learned: Through out the sessions of the course, I get to understand the real picture of our society on enforcement of transitional justice. We used to talk a lot and write a lot about injustice happening in our society but before participating this course, I did not find out the way that why Justice fails and injustice stays! But now I understand. When I did my weekly activities, I search for human rights violation around me in this society and I get to understand the real scenario. I

also learned about an well organised and interactive online course, which has no comparison to make.

How are you going to apply what you learnt during the course in your own life and work?

With this course I understand the significant value of transitional justice. Thus I would like to apply the Impact of

the course in my own life in 3 way.

A. Analysing the Past,

B. Orchestrating the future and

C. Installation in the present.
